#### 1. Situation

- a. Significant events and incidents occur that require timely, accurate and efficient notification of the chain of command to ensure commanders are aware and that appropriate action is being taken.
- b. The reporting format, time requirement for submission, and distribution requirements for an incident report vary based on the nature, gravity, publicity, and potential impact to operational readiness of the incident.
- c. References (a) through (c) identify the requirements, formats, and timelines for reporting significant incidents and events to the Commandant of the Marine Corps; Commander, Marine Corps Installations Command (COMMCICOM); and Commander, Marine Forces North (COMMARFORNORTH). Reference (d) defines the use of C4I Suite for reporting force protection related events. Reference (e) provides reporting guidance for Unmanned Aircraft System (UAS) incidents and reference (f) identifies suspicious activity reporting requirements.

Reference (g) identifies reporting requirements associated with prohibited activities and conduct. Reference (h) identifies casualty reporting requirements and procedures.

- d. This order summarizes the reportable events and incidents into a consolidated directive that allows commands and organizations located on Marine Corps Installations National Capital Region Marine Corps Base Quantico (MCINCR-MCBQ) to quickly identify what must be reported, to whom, and in what time frame.
- 2. <u>Mission</u>. MCINCR-MCBQ reports significant incidents and events in accordance with the references and this Order to ensure the chain of command is promptly and properly informed.

## 3. Execution

#### a. Commander's Intent

- (1) <u>Purpose</u>. The purpose of this Order is to establish policy to ensure that MCINCR-MCBQ complies with higher headquarters reporting requirements in order to keep the chain of command informed of significant incidents or events.
- (2) <u>Method</u>. Develop, publish, and implement specific reporting requirements for OPREP-3 Serious Incident Reports (SIR), Blue Dart acknowledgement reports, threat reports, and to ensure CCIRs are appropriately reported.
  - (3) Endstate. Efficient, accurate, and timely reporting.

#### b. Concept of Operations

- (1) Upon notification of an incident or event occurring on MCINCR-MCBQ or an off-base incident involving Marines, dependents, or employees assigned to commands located on MCINCR-MCBQ, the list of reportable events identified in enclosures (1) and (5) should be reviewed.
- (2) If the incident requires an OPREP-3/SIR, it will generally be submitted by the organization impacted by the incident, or the organization to which the involved personnel are assigned. Coordination with the MCINCR-MCBQ G-3 (during working hours) or the MCINCR-MCBQ Command Duty Officer (CDO) (during non-working hours) should be conducted if the details of the incident make it unclear as to who is responsible for submitting the report (i.e. an installation or H&S Battalion incident versus tenant/subordinate command incident). In all cases, at a minimum, the MCINCR-MCBQ G-3 or CDO shall be informed of all OPREP-3/SIR reports concerning incidents involving MCINCR-MCBQ facilities or Marines, dependents, or employees assigned to commands located on MCINCR-MCBQ.
  - (3) Incidents requiring reporting to Commander MCINCR-MCBQ

shall first notify the MCINCR-MCBQ G-3 (during working hours) or CDO during non-working hours. Command point of contact information is located in encl (2).

- (4) Incidents requiring notification to COMMCICOM, COMMARFORNORTH, or posting on C4I Suite, Marine Corps Suspicious Activity Information Portal (MCSAIP) and e-Guardian shall be submitted to the MCINCR-MCBQ G-3 (during working hours) or the MCINCR-MCBQ CDO (during non-working hours) for processing and further dissemination/reporting.
- (5) Incidents that result in active duty, retired, or reserve military casualties or deaths of active duty family members, and civilian government employees may require that a Personnel Casualty Report (PCR) be submitted in accordance with the procedures identified in reference (h).

#### c. Tasks

- (1) Commanding Officer, Headquarters and Service Battalion (H&SBn)  $\hspace{1cm}$
- (a) Responsible for reporting incidents involving command personnel.
- (b) Coordinate with tenant commands/activities as necessary in order to avoid duplicative reporting and to eliminate any reporting gaps/seams (particularly in cases of personnel administratively assigned to H&S Bn, but OPCON to a tenant command/activity).
- (c) Notify the MCINCR-MCBQ G-3 (working hours) or the MCINCR-MCBQ CDO (non-working hours) by phone and email upon becoming aware of an incident that meets criteria for reporting as identified in enclosures (1).
  - (2) Commanding Officer, Security Battalion (SecBn)
- (a) Responsible for reporting incidents involving command personnel.
- (b) Coordinate with the MCINCR-MCBQ G-3 to ensure notification and reporting of incidents in which no clear chain of command exists (i.e. incidents involving individuals with no direct affiliation with a base organization).
- (c) Notify the MCINCR-MCBQ G-3 (working hours) or the MCINCR-MCBQ CDO (non-working hours) by phone and email upon becoming aware of an incident that meets criteria for reporting as identified in enclosure (1).
  - (3) Commanding Officer, Marine Corps Air Facility Quantico

### (MCAF)

- (a) Responsible for reporting incidents involving command personnel.
- (b) Coordinate with Commanding Officer, HMX-1 for submitting reports concerning incidents involving HMX-1 aircraft or personnel.
- (c) Notify the MCINCR-MCBQ G-3 (working hours) or the MCINCR-MCBQ CDO (non-working hours) by phone and email upon becoming aware of an incident that meets criteria for reporting as identified in enclosure (1).

#### (4) AC/S G-1

- (a) Ensure CDO's are thoroughly briefed on the provisions of this Order and have the necessary references to submit voice OPREP-3 reports and C4I Suite posts within specified timelines if directed.
- (b) Be prepared to release follow-up, hard-copy, OPREP-3 messages within specified timelines, if required.

### (5) AC/S G-3

- (a) Assume overall staff cognizance for ensuring MCINCR-MCBQ submits required incident reports as identified in the references.
- (b) Coordinate with the Commanding Officers of H&S Bn, Sec Bn, MCAFQ, and the Commanders/Directors of tenant commands and activities to ensure reporting involving personnel and facilities located on or assigned to MCBQ are reported IAW the references.

#### (6) Commanders/Directors, Tenant Commands, & Activities

- (a) Responsible for reporting incidents involving command personnel.
- (b) Notify the MCINCR-MCBQ G-3 (working hours) or the MCINCR-MCBQ CDO (non-working hours) by phone and email upon becoming aware of an incident that meets criteria for reporting as identified in enclosure (1).

# d. Coordinating Instructions

- (1) When required, personal notification to COMMCICOM, from Commander MCINCR-MCBQ, will be via phone and email using a "Who, What, Where, When, Why" format.
- (2) Include MCINCR-MCBQ as an info addressee on all OPREP-3/SIR reports involving MCBQ facilities or Marines, civilian employees

or family members assigned to MCINCR-MCBQ (utilize the following Message PLA: MCINCR MCBQ Commander).

(3) Enclosure (5) provides a quick reference guide to facilitate determination of who needs to be notified of the incident, the type of report required, and the timeframe for reporting.

# 4. Administration and Logistics

- a. A current copy of this Order shall be maintained in the CDO binder.
- b. Upon submission of any Automated Message Handling System (AMHS) report as directed in the provisions of this Order, notification to recipients via NIPR email is also required.
- d. This Order will be reviewed and updated on an annual basis.5. Command and Signal

#### a. Command

- (1) This Order is applicable to MCINCR-MCBQ and MCAFQ.
- (2) Commander, MCINCR-MCBQ or his staff shall coordinate with tenant commands/activities located on MCINCR-MCBQ to ensure compliance with all higher-headquarters reporting requirements as identified in this Order.
- b.  $\underline{\text{Signal}}$ . Enclosures (2) provides key phone/contact and AMHS address information applicable to this Order.

# UAS Reporting

An OPREP-3 Voice Report to the MCOC is required within (30) minutes of a confirmed UAS sighting and a follow up AMHS message within (3) hours. The initial report should include as much data as is available, including the following (if known):

- 1. Description of the aerial object or device, color, identifying markings, actual size, manufacturer and type (rotary, quad-copter, fixed-wing, etc.)
- 2. Distance from observer, direction or flight path and loiter activity.
- 3. Payload, observable camera or other device.
- 4. Any/all actions taken, including interactions with law enforcement or other agencies
- 5. If possible, units will send high definition pictures of the UA

The follow up AMHS message should include updated information since the initial voice report and any mitigation measures taken (e.g. increased security measures, the use of force with the intent to damage, destroy or disable the UA such as a net gun, drone buster, drone defender, etc.) and any mission impact. MARFORNORTH shall be included as an info addressee on the AMHS message.

# Suspicious Activity

Suspicious activity reporting (SAR) facilitates information sharing and future analysis by the Marine Corps, DoD and federal law enforcement agencies. Listed below are descriptions of the fourteen (14) categories of suspicious activity that must be reported IAW reference (f).

- 1. Vehicle and personnel breach/attempted intrusions. Unauthorized personnel attempting to enter or actually entering. Perimeter boundaries and interior enclaves.
- 2. Misrepresentation. Presenting false information or misusing insignia, documents, and/or identification to misrepresent one's affiliation as a means of concealing possible illegal activity.
- 3. Theft/loss/diversion. Stealing or diverting something associated with a facility/infrastructure or secured protected site (e.g., badges, uniforms, identification, emergency vehicles, technology, or documents (classified or unclassified), which are proprietary to the facility/infrastructure or secured protected site.
- 4. Sabotage/tampering/vandalism. Damaging, manipulating, defacing, or destroying part of a facility/infrastructure or secured protected site.
- 5. Expressed/implied threats. Communicating a spoken or written threat to commit a crime that will result in death or bodily injury to another person or persons or to damage or compromise a facility/infrastructure or secured protected site.
- 6. Aviation activity. Learning to operate, or operating an aircraft, or interfering with the operation of an aircraft in a manner that poses a threat of harm to people or property, to included UAS incursions, sightings, overflight, loitering or other activity in or over perimeter boundaries.
- 7. **Elicitation**. Questioning individuals or otherwise soliciting information at a level beyond mere curiosity about a public or private event or particular facets of a facility/building purpose, operations, security procedures, etc.
- 8. Testing/probing of security. Deliberate interactions with, or challenges to, installations, personnel, or systems that reveal physical, personnel, or cybersecurity capabilities.\
- 9. Recruiting/financing. Providing direct financial support to operations teams and contacts or building operations teams and contacts; compiling personnel data, banking data, or travel data in a manner that would arouse suspicion of terrorism or other criminality in a reasonable person.

- 10. Unauthorized/suspicious photography. Taking pictures or video of persons, facilities, buildings, or infrastructure in an unusual or surreptitious manner that would arouse suspicion of terrorism or other criminality in a reasonable person. Examples include taking pictures or video of infrequently used access points, the superstructure of a bridge, personnel performing security functions (e.g., patrols, badge/vehicle checking), security-related equipment (e.g., perimeter fencing, security cameras), etc.
- 11. Observation/surveillance. Demonstrating unusual or prolonged interest in facilities, buildings, or infrastructure beyond mere casual (e.g., tourists) or professional (e.g., engineers) interest and in a manner that would arouse suspicion of terrorism or other criminality in a reasonable person. Examples include observation through binoculars, taking notes, attempting to mark off or measure distances, etc.
- 12. Materials acquisition/storage. Acquisition and/or storage of unusual quantities of materials such as cell phones, pagers, radio control toy servos or controllers(semicolon) fuel, chemicals, or toxic materials(semicolon) and timers or other triggering devices, in a manner that would arouse suspicion of terrorism or other criminality in a reasonable person.
- 13. Acquisition of expertise. Attempts to obtain or conduct training or otherwise obtain knowledge or skills in security concepts, military weapons or tactics, or other unusual capabilities in a manner that would arouse suspicion of terrorism or other criminality.
- 14. Weapons collection/discovery. Collection or discovery of unusual amounts or types of weapons, including explosives, chemicals, and other destructive materials, or evidence, detonations or other residue, wounds, or chemical burns that would arouse suspicion of terrorism or other criminality.
