



## **Major Aaron M. Wellman**

Major Wellman was commissioned in 2007 following completion of Officer Candidate Course. Upon graduation from The Basic School and the U.S. Army Military Police School Basic Officer Leadership Course, Major Wellman reported to Marine Wing Support Squadron-273, Marine Corps Air Station Beaufort, South Carolina where he served as the Incident Response Platoon Commander.

In 2008, he was reassigned to Marine Wing Support Squadron-271, Marine Corps Air Station Cherry Point, North Carolina to serve as Platoon Commander for deployment with Marine Wing Support Group-27 Military Police Company. From September 2008 to April 2009 he deployed with Task Force Military Police, 1st Battalion, 12th Marines in support of Operation Iraqi Freedom 08.2.

Returning from deployment, Major Wellman was transferred to the consolidated Provost Marshal's Office for Marine Corps Air Station Beaufort and Marine Corps Recruit Depot Parris Island, South Carolina. In this capacity he served as District Officer In Charge and Assistant Operations Officer.

In 2010 Major Wellman was selected to attend the U.S. Army Military Police School Captains' Career Course. Upon completion of the course he was assigned to Military Police Instruction Company, Marine Corps Detachment, Fort Leonard Wood, Missouri. Here he served as Executive Officer, Academics Officer and Course Officer In Charge of the Military Police Officer Basic Course.

In 2013 he executed orders to 1st Law Enforcement Battalion, Camp Pendleton, California. Shortly after checking in, he was attached to I Marine Expeditionary Force (Forward) for deployment as the Anti-Terrorism / Force Protection (AT/FP) Officer. From December 2013 to November 2014 he served as the AT/FP Officer for Regional Command (Southwest), Marine Expeditionary Brigade - Afghanistan in support of Operation Enduring Freedom 14.1.

Returning from deployment in December 2014, Major Wellman assumed command of Company C, 1st Law Enforcement Battalion. After relinquishing command in April 2016, Major Wellman assumed duties as Operations Officer for 1st Law Enforcement Battalion's participation in exercise KHAAN QUEST 16 (Mongolia).

In July 2016, Major Wellman was reassigned to Marine Forces Northern Command, New Orleans, Louisiana where he served as the G-3/5/7 Deputy Current Operations Officer.

In July 2019, Major Wellman assumed the duties of Provost Marshal, Marine Corps Installations National Capital Region-Marine Corps Base Quantico.

Major Wellman's personal decorations include the Meritorious Service Medal, Navy and Marine Corps Commendation Medal (with Gold Star in lieu of Second Award) and the Navy and Marine Corps Achievement Medal. He holds a Bachelor of Science degree in Justice Administration from the University of Louisville, a Master of Arts degree in Business and Organizational Security Management from Webster University, and Master of Arts degree in Security Studies (Homeland Security and Homeland Defense) from the Naval Postgraduate School, Center for Homeland Defense and Security.
