1. Situation. To promulgate policy and establish procedures for the selection of exceptionally qualified nominees for Marine and Noncommissioned Officer of the Quarter/Year.

2. Cancellation. MCINCR-MCBQO 1650.2.

3. Mission. Marine Corps Installations National Capital Region-Marine Corps Base Quantico (MCINCR-MCBQ) will recognize Quarterly and Annually those Marines nominated by tenant commands for outstanding leadership and sustained performance of duty of our exceptionally well-qualified Marines.

4. Execution

a. Commander's Intent and Concept of Operations

(1) Commander's Intent. To screen, select and recognize outstanding Marines and Noncommissioned Officers within MCINCR-MCBQ based on overall performance which exceeds normal expectations and demonstrates efforts of self-improvement, unit improvement, displayed leadership qualities, and overall potential during the Quarter/Year.

(2) Concept of Operations. On a Quarterly and Calendar Year timeframe, MCINCR-MCBQ will select the most qualified and exemplary nomination submitted by the tenant commands as the MCINCR-MCBQ Marine and Noncommissioned Officer of the Quarter/Year.

(a) An electronic board will be conducted on the second full week of the month immediately following the quarter.

(b) Nomination packages are due to the MCINCR-MCBQ Adjutant section by the first Thursday of the month immediately following the quarter.

b. Tasks

(1) Commanders and Sergeants Major. Disseminate this Bulletin for maximum visibility and apply strict screening procedures while adhering to the prescribed deadlines. Nominate outstanding Marines, under your charge, who meet the requirements set forth in this Bulletin.

(2) Unit S-1/Sergeants Major

(a) Utilize the dates below to initiate preparation of packages far enough in advance to allow for a thorough review and timely submission via the chain of command.

(b) Prior to submission to the MCINCR-MCBQ Adjutant Section, validate eligibility requirements, administrative correctness of the packages, and the presence of required material to ensure a complete submission. Nomination packages are expected to be screened and submitted by the unit S-1 to the Adjutant Section via SharePoint: [https://usmc.sharepoint-mil.us/sites/MCINCR\\_quantico\\_workflow\\_paperwork](https://usmc.sharepoint-mil.us/sites/MCINCR_quantico_workflow_paperwork).

(3) MCINCR-MCBQ Adjutant Section

(a) Receive and screen nomination packages from tenant commands for accuracy and completeness.

(b) Coordinate a location and time for the board with the MCINCR-MCBQ Sergeant Major.

(c) Submit, print, and route a Certificate of Commendation for all winners of the MCINCR-MCBQ Marine and Noncommissioned Officer of the Quarter.

(d) Submit, print, and route an impact Navy and Marine Corps Achievement Medal for all winners of the MCINCR-MCBQ Marine and Noncommissioned Officer of the Year.

c. Coordinating Instructions

(1) MCINCR-MCBQ Sergeant Major will serve as the senior member of the Noncommissioned Officer and Marine of the Quarter/Year electronic boards. Board members will be assigned by the MCINCR-MCBQ Sergeant Major.

(2) Lance Corporals and below will be eligible for Marine of the Quarter/Year. Corporals and Sergeants will be considered for the Noncommissioned Officer of the Quarter/Year.

(3) The following Commanders may nominate Marines for the subject awards:

(a) Commanding Officer, Security Battalion

- (b) Commanding Officer, Marine Corps Air Facility
- (c) Commanding Officer, Marine Corps Information Operation Center
- (d) Commanding Officer, Marine Corps Intelligence Activity
- (e) Commanding Officer, Wounded Warrior Regiment
- (f) Commanding Officer, Marine Aviation Detachment (MAD) Patuxent River
- (g) Commanding Officer, Marine Helicopter Squadron One
- (h) Commanding Officer, Marine Corps Embassy Security Group
- (i) Commanding Officer, Headquarters and Service Battalion, HQMC

(4) To submit a nominee for Marine or Noncommissioned Officer of the Year, the nominee must have previously won a Marine or Noncommissioned Officer of the Quarter board unless otherwise approved by the MCINCR-MCBQ Sergeant Major.

(5) The minimum criteria for all nominees are:

(a) First class scores on the most recent Physical Fitness Test and Combat Fitness Test.

(b) Score of Sharpshooter or higher on most recent Annual Rifle Qualification.

(c) Current Water Survival.

(d) Marine Corps Martial Arts Program: Grey Belt (Marine of the Quarter/Year), Grey Belt (Noncommissioned Officer of the Quarter/Year).

(e) Nominees must have not received derogatory page 11 entries, been subject to disciplinary action, or have been involved in alcohol-related incidents within 12 months of nomination.

(f) Read and completed at least one book report from the Commandant's reading list.

(6) Marine and Noncommissioned Officer of the Quarter winners will receive a Certificate of Commendation from the MCINCR-MCBQ Base Commander.

(7) Marine and Noncommissioned Officer of the year winners will receive a Navy and Marine Corps Achievement Medal from the MCINCR-MCBQ Commander.

## 5. Administration and Logistics

### a. Administration

(1) Nominations. Each tenant command listed in paragraph 4.c.(3) is allotted one nominee submission for Marine and Noncommissioned Officer of the Quarter/Year. Winners of the board will be announced upon completion of the board.

(2) Nomination Packages. Each nomination package will meet the requirements set forth in this Bulletin and submitted using the template provide in Enclosure (1).

b. Logistics. Upon notification, units must provide a physical copy of a professional promotion photo of the winner taken in Service Alphas to be displayed in Lejuene Hall.
